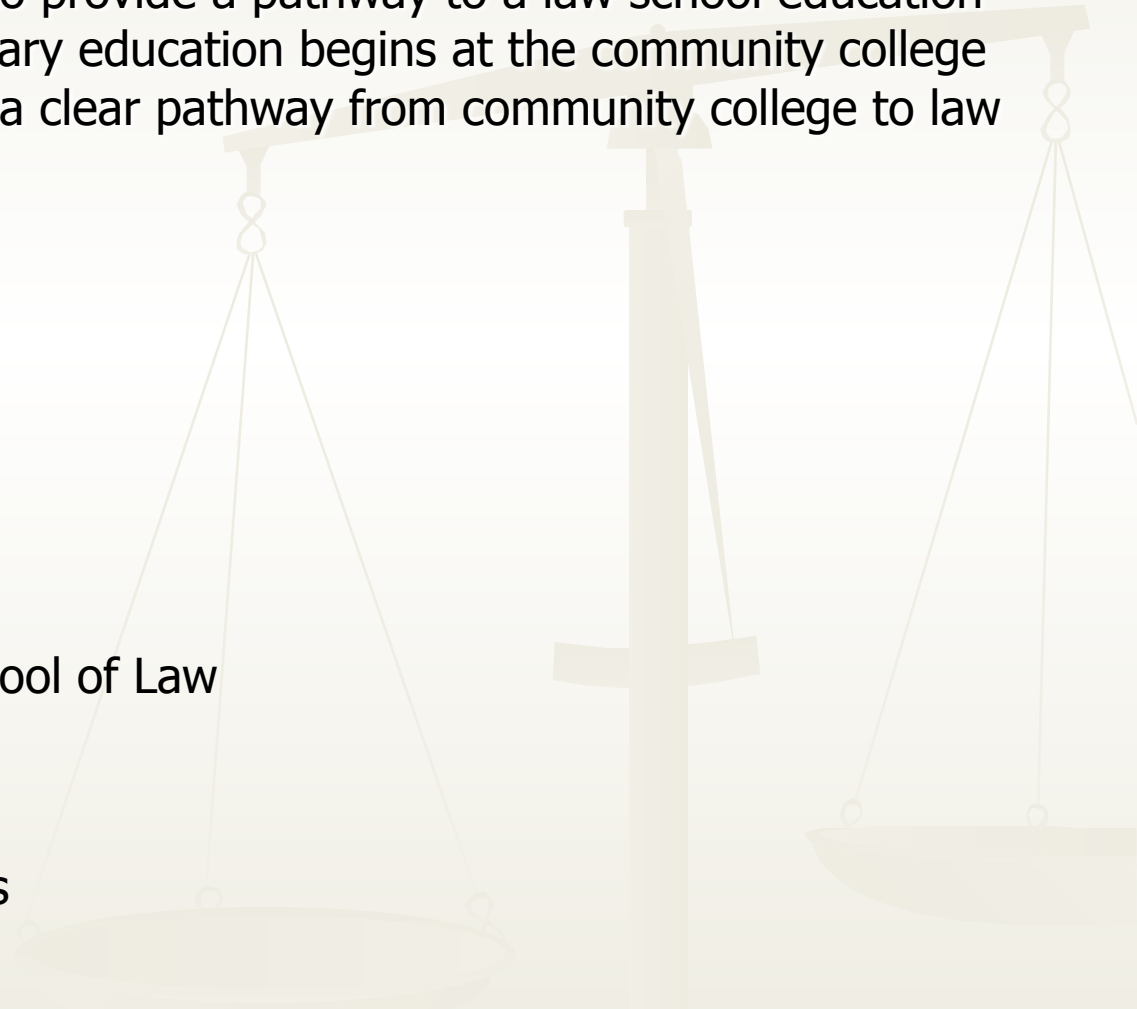

PURPOSE


The purpose of the program is to provide a pathway to a law school education for students whose post-secondary education begins at the community college level. This program will provide a clear pathway from community college to law school.

PATHWAY BENEFITS


- Pathway students are provided with the academic foundation necessary for successful transfer and eventual entry to law school;

REQUIREMENTS




- ✓ Complete the Orientation (Your are here!)
- ✓ Complete the required core courses:
 - ❖ English 101, College Reading and Composition 1 (3 units)
 - ❖ English 103, Composition and Critical Thinking (3 units)
 - ❖ History 11, Political and Social History of the U.S. (3 units)
 - ❖ Law 1, Business Law or Law 10, Intro to Law (3 units each)
 - ❖ Philosophy 6, Logic (3 units) or Math 227, Statistics (4 units)
 - ❖ Law 16, Evidence (3 units)
 - ❖ Political Science 1, The Government of the U.S. (3 units)
 - ❖ Additional Suggested Course: Counseling 17,
College Survival Skills (1 unit)
- ✓ Register with the Program and follow the educational plan to complete the required courses
- ✓ Maintain good standing academically, as well as ethical standards for admission to the State Bar.

The Competitive Edge

- The core courses will bolster your academic preparation leading to higher scores on the Law School Admissions Test (LSAT) and in law school.
 - Fee waivers help with the financial burden of applying to different law schools.
